  - a) High School-
    - (1) Dr. Johnson reported with a lengthy discussion with the board members about student grades at the highschool and the effort and strategies that the teachers and staff were implementing to ensure that students were turning in work and passing classes. Since the Thanksgiving break time, students have started turning in late work and assignments that were overdue by as many as six weeks. Numbers of students with failing grades were listed at 72 at Thanksgiving break and have improved by 30 students. More work is being turned in and will be graded until Christmas break.
    - (2) All Chromebooks will be turned in and redistributed in Carts in the classrooms. Chromebooks will be kept on campus and not taken home. In order to be exempt from semester tests, students must turn in their chromebooks before the testing dates.
    - (3) Atlas Science Test that was given to students from the new state mandated interim testing.
      - (a) 7th Grade State Avg was 89 with Midland at 87
      - (b) 8th Grade State Avg was 91 with Midland at 96
      - (c) Biology State Avg was 95 with Midland at 95

# XV. Required Training

A.C.A. § 6-13-629 requires annual professional development for Arkansas school board members:

- All school board members must acquire at least six (6) hours of training every calendar year.
- Newly elected board members must achieve at least nine (9) hours of training by December 31 of the calendar year that follows the calendar year of their initial election that includes training on the following topics:
  - How to read and interpret an audit; and
  - School safety and student discipline.
- School districts must publish in their annual reports the number of training hours each board member has earned.
- If a board member fails to meet the annual training requirement, the board member must be removed from the school district board of directors unless:
  - The board member received the number of training hours the board member was deficient between January 1 and a thirty (30) day period following the school district's January board meeting; or
  - The reason the board member was unable to receive the number of deficient training hours during the cure period was due to the board member's military service or an illness that is attested by the board member's treating physician.
- Failure for the board to remove a board member who failed to meet the annual training requirement and who does not meet one of the above exceptions may result in the school district being placed on probationary status for violating the Standards For Accreditation.
- The Division of Elementary and Secondary Education rules allow carryover of excess board training hours for up to three calendar years.

Recognizing the important role the school board has in maintaining the school district's fiscal status, the Arkansas General Assembly requires that the initial nine (9) hours of training a board member receives include training related to how to read and interpret a school audit. Act 182 of 2021 also requires that all board members receive training in student safety and student discipline during their initial nine (9) hours of training.
