- V. Approval to accept the resignation of Juliet Batategas at the end of the 2023-24 school year. (4-6th grade science teacher)

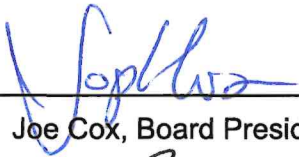

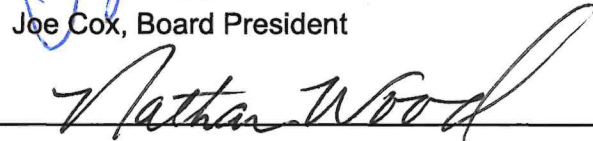
