Immunization Statement of Assurance

Midland School District, in compliance with the Arkansas Department of Health, requires immunizations of all students enrolled. Students who are not age appropriately immunized will not be permitted to attend class.

A student may temporarily be admitted provided that the student becomes appropriately immunized, is in-process of receiving the needed doses of vaccine, or shows proof that they have applied for an exemption for those vaccines he/she has not received within thirty (30) calendar days after the child's original admission or by October 1st.

The District will maintain a list of all students who are not fully age appropriately immunized or have an exemption based on medical, religious, or philosophical grounds.

Proof of Immunization records will only be accepted by:

- Licensed Physician
- Health Department
- Military Service
- Official record from another educational institute in Arkansas
