

**PUBLIC RELEASE – SY 2025-2026
FOR FREE AND REDUCED PRICE MEALS**

Midland School District will be participating in the **National School Lunch Program and School Breakfast Program**. Households may be eligible for free or reduced price meal benefits. Applications may be found **in back to school informational packets or in the main office of either campus**. Households that participate in the Special Supplemental Nutrition Program for Women, Infants and Children (WIC) may be eligible for free or reduced price meals. To apply for free or reduced price meals, households must complete and return the application. Applications will be considered incomplete if all information is not provided as described in the instructions provided with the application. Applications may be submitted at any time during the school year as circumstances change provided that the loss of income causes the household income during the period of unemployment to be within the eligibility criteria.

Households with children who received Supplemental Nutrition Assistance Program (SNAP) benefits. may submit an application with abbreviated information as described in the application instructions.

All applications are subject to verification. Parents or guardians dissatisfied with the ruling of the determining official may wish to discuss the decision with the determining official on an informal basis. Children who are enrolled in Head Start / Even Start programs are categorically eligible for free meals. Contact **Valarie Hibbitts** at 501-345-8801 with questions regarding Head Start / Even Start meal benefits.

Children certified as foster, migrant, homeless or runaway by the district are categorically eligible for free meals. Contact **Courtney Turner** at 501-345-2413 with questions regarding foster, migrant, homeless or runaway meal benefits.

Households who are notified of their eligibility but who do not want their children to receive free meals must contact the school. SNAP households should complete an application if they are not notified of their eligibility by **August 20,2025**.
