To apply for free or reduced price meals, households must complete and return the application. Applications will be considered incomplete if all information is not provided as described in the instructions provided with the application. Applications may be submitted at any time during the school year as circumstances change provided that the loss of income causes the household income during the period of unemployment to be within the eligibility criteria.

All applications are subject to verification. Parents or guardians dissatisfied with the ruling of the determining official may wish to discuss the decision with the determining official on an informal basis. Children certified as foster, migrant, homeless or runaway by the district are categorically eligible for free meals. Contact Courtney Turner at 501-345-2413 with questions regarding foster, migrant, homeless or runaway meal benefits.

Households who are notified of their eligibility but who do not want their children to receive free meals must contact the school. SNAP households should complete an application if they are not notified of their eligibility by August 20,2025.
